EUROPEAN CONDITIONS OF ENTRY

- Non-European shooters may take part in the Championship and are eligible to win class and open cash prizes but are not eligible to win medals in the open, categories or classes
- Prize Fund of €10,500 is subject to 350 entries, amended pro rata
- ** Participants whose class is not set to ICTSA (ICTSC) cut off points must give their current class percentage and they will be classed accordingly
- The closing date for the receipt of entries is 14/07/2023
- All entry fees must be paid in full at time of entry
- ICTSA rules and regulations will apply
- The rules of DTL as per CPSA booklet 7 will apply
- Starting time 9.00am sharp daily
- Individual Lady, Junior, Veteran and Super-Veteran Category winners to third place will receive a medal
- Individual Open winners to third place will be removed from their class and receive a medal plus a cash prize
- Class winners to third place will receive a medal plus a cash prize
- Participants may be awarded a Category and a Class prize simultaneously
- European National Team Events ICTSC member Associations/Federations (Maximum 3Teams per Category)
 - Open Team: Teams of 5 4 scores to count (Additional entry fee €50)
 - Ladies Team: Team of 3 2 scores to count (Additional entry fee €40)
 - Junior Team: Team of 3 2 scores to count (Additional entry fee €40)
 - Veteran Team: Team of 3 2 scores to count (Additional entry fee €40)
 - Super-Veteran Team: Team of 3 2 scores to count (Additional entry fee €40)
- Team ties will be decided at the end of day 2
- Any individual awarded an ICTSC perpetual award will be responsible for the safe keeping and insurance of same
- While every effort will be made to retain participants in the squad in which they entered, the organisers reserve
 the right to move participants from one squad to another, in order to fill squads etc.Participants wishing to be
 squadded together must enter in the same squad.
- Where possible competitors will start on their preferred stand number as requested on entry. However, where
 other competitors have requested the same stand number, the second (and subsequent) competitor/s to enter
 will be squadded in the closest available alternative stand.
- In the event of any participant not being able to produce a classification they will be classified as per the ICTSA regulations
- All shooters must sign the score sheet after each 25 targets. Once a shooter has signed their score sheet
 they have accepted their score and any score sheet not carrying the shooters signature will be credited with
 the lowest score recorded
- Any shooter interfering with or attempting to interfere with the traps without authority will be penalised FIVE (5) TARGETS
- All protests to the jury must be submitted in writing accompanied by a fee of €100
- The jury's decision will be final
- An acceptable standard of dress is required for all competitors
- All Competitors must comply with Firearms Licensing Laws of Ireland. Visitors permits can be arranged and may take up to 6-8 weeks to process with the authorities. Further details are available from ICTSA
- No refund will be issued for entry cancellations or withdrawals after —31st May 2023
