



## Memorandum of Understanding

Between

Clay Pigeon Shooting Association – ENGLAND

Irish Clay Pigeon Shooting Association – IRELAND

Ulster Clay Pigeon Shooting Association – NORTHERN IRELAND

Scottish Clay Target Association - SCOTLAND

Welsh Clay Target Shooting Association - WALES



This Memorandum of Understanding (MOU) sets for the terms and understanding between the CPSA, ICPSA, UCPSA, SCTA and WCTSA hereinafter called the "Council" to administer, award, conduct and regulate the Home Countries International and Invitational Tournaments.

### **Management**

The management of the affairs of the Council shall be conducted by an Executive Committee which shall have full executive powers to deal with all matters concerning the council as are not expressly provided for in the ICTSC Bye-Laws and with any resolutions that may be passed from time to time at a General Meeting of the Council.

The Executive Committee shall consist of TWO [2] elected or appointed individual members from each of the council members. TEN [10] in total. Each member shall have one [1] vote.

### **Rules & Bye-Laws**

The Executive Committee may from time to time make such Rules or Bye-Laws as they may deem necessary or expedient or convenient for the proper conduct and management of the Council's business or for the fulfilment of its aims and objectives.

### **Meetings**

The Executive Committee shall meet at intervals not greater than six [6] months and shall be convened by the Chairman. They shall hold no less than two [2] ordinary meetings in each calendar year. The quorum of the Executive Committee shall be six [6].

### **Chairman**

The Chairman shall be a member of the Executive Committee. The office of Chairman shall rotate from year to year with the host association of the DTL HCIT and the Chair transfers to next host country after the DTL HCIT.

### **Funding**

All council members shall be obliged to pay an annual levy and/or affiliation fee as determined by the Executive Committee each year. A balance sheet must be made out in every year and laid before the Council in General Meeting, made up to a date not more than three [3] months before such meeting.

### **Council Assets**

All council assets shall remain the property of the ICTSC at all times. All assets of the Council shall be stored at locations as directed by the Executive Committee.

### **Duration**

This MOU is at-will and may be modified by mutual consent of authorized officials from the CPSA, ICPSA, UCPSA, SCTA and WCTSA. This MOU shall become effective upon signature by the authorized officials from the CPSA, ICPSA, UCPSA, SCTA and WCTSA and will remain in effect until modified or terminated by any one of the partners by mutual consent.
